

The ACI-LAC Green Airports Recognition aims to promote environmental best practices to minimize aviation's impact on the environment and to recognize airport members who have outstanding accomplishments in their environmental projects.

This year, the Green Airports Recognition is supported by our World Business Partner (WBP) **TAV Technologies**, one of the leading one of the leading company in airport IT industry.

ACI-LAC Airport Members can submit their outstanding projects in one of the following categories: Mitigation and adaptation to Climate Change, and Circular Economy (circularity of products and materials – water, waste, among others). All participating projects that meet the criteria will receive the ACI-LAC Green Airport Recognition. This year ACI-LAC will also honor projects that achieve outstanding performance in each of the categories listed above with a **Special Recognition**.

The recognized projects will be announced during the ACI-LAC Annual Conference and Exhibition 2023 to be held in Miami (November 6-7) and will be captured in the Green Airports Recognition publication.

By participating in this initiative, airports can share their environmental projects and have the chance to be recognized for their achievements. This initiative is coordinated with the support of the ACI-LAC Environment and Sustainability Committee.

## INSTRUCTIONS FOR PARTICIPATION AND ELIGIBILITY

All projects/programs will be eligible if they have been implemented within the last 3 years. Applications must be limited to the following categories: **Mitigation and adaptation to Climate Change, and Circular Economy.** 

All applications that meet the recognition criteria will receive the Green Airport Recognition and will be included in environmental best practices document. This year ACI-LAC will honour projects that achieve outstanding achievements in each of the categories listed above with a **Special Recognition**.

## AIRPORTS OR AIRPORT GROUPS INTERESTED IN PARTICIPATING MAY ONLY SUBMIT ONE (1) PROJECT.

### SUBMISSION DEADLINE: SEPTEMBER 20, 2023

The submitted projects or programs will be assessed based on the recognition criteria listed below:

- Involvement of the airport's senior management
- Profitability (cost-effectiveness)
- Sustainability Benefit
- Innovation

#### Applications must meet with the word limit established in the application form.

#### **Best Practices Document**

All the initiatives recognized by the panel of judges will be included in the Best Environmental Practices Document that will be shared with all ACI-LAC members and included in the ACI-LAC website.

#### Panel of Judges

The panel of judges will review the applications and select the environmental projects suitable to receive the green airport recognition and the Special Recognition in each of the 2 categories. The Panel of judges will be formed by experts in the environmental field.
