## **Executive Summary**

Our corporate strategy is focused on strengthening our commitment to sustainability, through our sustainability policy with the objective of transforming our operation to provide a better service and experience to our visitors and promoting close and effective relationships with our stakeholders.

In accordance with this policy, our action pillars and their results are classified as follows:

- Competitive Connections: Infrastructure, Competitiveness, User and Customer Experience, Supply Chain.
- Connections with the planet: Climate change, Circular Economy, Water, Biodiversity.
- Closer connections for inclusion: Human talent, Safety and health in airport operations, Stakeholders.
- Transforming connections: Strategic Relationship, Human Rights, Ethics, compliance and transparency.

This classification was made taking as a base input the materiality exercise carried out in 2019 with the objective of identifying the most relevant work focuses for the next 7 years, which were analyzed, validated and approved by the Steering Committee and the Board of Directors.

Promoting close relationships with our stakeholders and focusing on the commitment to sustainable development, El Dorado decided to develop a Stakeholder Partnership Plan to document the efforts being developed with third parties led by the climate change component and supported by the components of circular economy, water resource management and biodiversity in order to achieve effective and significant reductions that do not affect the continuity of the business and allow identifying new development opportunities that make El Dorado stand out as a sustainable connection center with the country and the world.

## **Project Results and Benefits**

As for the results obtained, we have currently achieved vehicle fleet renewal commitments for the years 2023 and 2024 with our third parties. In addition, we expect more companies to join our electric mobility plan in the near future.

Within our management of the socialization plan, we have identified multiple initiatives being developed by both airlines and ground handling companies, all aimed at reducing emissions. These

initiatives include the training of personnel in the efficient use of machinery, implementation of applications to optimize the use of resources, data analysis for better time management, as well as the renewal of equipment, among other advances.

It is essential to highlight that this level of participation has been possible thanks to the effective collaboration and communication between the airport and all stakeholders. We have worked hand in hand with these parties to understand their needs and opportunities for cooperation, integrating their contributions into the concessionaire's development plans.

Among the benefits:

1. El Dorado Airport, widely recognized for its commitment to sustainability, has contributed to the development and promotion of emission reduction strategies. This aligns with our corporate values of creating transformative and competitive connections. We seek to provide a resilient infrastructure that can adapt to new needs arising from changes in airport operations.

2. The implementation of the first phases of Airport Collaborative Decision Making (ACDM) has given us access to real-time data that is used for analytics and to improve operational efficiency, as well as to measure our emissions more accurately. This strategy has connected us more closely to relevant information.

3. We have achieved greater participation in inter-institutional and sectoral spaces, representing the concessionaire and working hand in hand with air transport and ground handling companies. This collaboration allows us to advance towards the fulfillment of the goals established by the sector.
